Union Pacific Staircase Reconstruction Update

September 6, 2013 - During the week of September 2nd Union Pacific Railroad continued work on the removal and reconstruction of the eastern and western stairways (Project) leading from the sidewalk along IL Rt. 176 to the Metra train station platforms. The easterly staircase is now open as all work has been completed except for landscape restoration. Union Pacific has completed the pouring of the concrete on the westerly staircase; however, the staircase will remain closed for an additional week until the new metal handrails are installed. According to Union Pacific the Project will be completed during the week of September 9th.

Fall Semi-Annual Collection Information

The fall semi-annual collection program provides Village residents an opportunity to dispose of items such as mattresses, furniture and barbeque grills (without propane tank) that are not picked up as part of the normal refuse collection. The semi-annual collection schedule is determined by regular collection dates; Pickup for Monday's refuse collection route is Wednesday, October 2nd and Tuesday's refuse collection route is scheduled for Wednesday, October 9th. Residents are reminded that all items are required to be placed at the curb no earlier than 4:00 p.m. the day prior to the collection.
