Recent Village Board Meeting (June 11). The Board:

- Appointed Tim Callahan to the Architectural Board of Review.
- Approved construction contracts for improvements to the Fire Station and the Water Tower.
- Updated an intergovernmental agreement concerning the Northern Illinois Police Alarm System (100+ agency special tactical squad for emergencies and crowd control).
- Approved a contract to start pay-by-phone parking in the Metra commuter lot.

Recent Historic Preservation Commission Meeting (June 13): The Commission:

- Recommended the Village Board approve a landmark nomination for 673 Maple Avenue.
- Approved modifications to the garage at 700 E. Center Avenue (Historic Landmark), and initiated an advisory review for the proposed demolition of two sheds and a greenhouse.
- Continued strategic planning and visioning; discussed historic architecture survey.

Upcoming Plan Commission and Zoning Board of Appeals Meeting (June 20): The PCZBA will:

- Conduct a workshop regarding the Comprehensive Plan.
