Recent Beach Parking Ad Hoc Committee Meeting (January 7). The Beach Parking Ad Hoc Committee continued to discuss beach parking issues, and recommended the Village Board not allow parking on Mountain Road, Simpson Avenue, and Maple Avenue south of Scranton Avenue.
